About the Canadian Risk Management (CRM) Designation

The CRM designation is a widely recognized qualification that provides risk managers a foundation of knowledge and skills needed to identify, assess, monitor and limit risks. The CRM is recognized by RIMS and awarded by the Global Risk Management Institute (GRMI).



Why Should You Earn Your CRM?

Competitiveness: Formal training gives you a competitive advantage that public and private employers seek.

Credentials: Demonstrate that you have achieved the knowledge and skills necessary to identify, assess, monitor and limit risks.

Recognition: Stand out among others and demonstrate your professional commitment, knowledge and skills.

Advancement: Improve your ability to achieve your organization's risk management objectives and your career goals.



Eligibility and Requirements

To earn the CRM designation, candidates need to complete three foundational courses, and pass a standardized exam for each course.

The courses, and the three corresponding exams, are based upon the content from the below listed books, written and published by The Institutes.

- ARM-54 Risk Management Principles and Practices
- ARM-55 Risk Assessment and Treatment
- ARM-56 Risk Financing

1. Create an online profile at www.RIMS.org/CRM.
2. Mail a copy of your official transcript/grade report from the university/institution where you took the course along with the CDN \$125 testing and processing fee for each exam in the form of a cheque made payable to GRMI. GRMI, upon receipt of the above and notification of a passing grade, will issue testing center location options and access instructions via email. Exams will be offered during four testing windows each year:
 - January 15 - March 15
 - April 15 - June 15
 - July 15 - September 15
 - October 15 - December 15
3. Once the candidate receives a passing score of 70% or higher on all three exams, GRMI will issue a CRM designation completion certificate.

Notes:

- Please allow up to six weeks to process your CRM certificate. Course tuition varies from one institution to another, and is independent of exam fees paid to the Global Risk Management Institute (GRMI).
- CRM candidates who completed at least one CRM course prior to April 30, 2015 need to contact GRMI at GRMI@RIMS.org to receive processing instructions.

Maintaining Continued Standing:

Once the CRM designation is granted, CRM holders must maintain their credentialed membership with GRMI by paying a USD \$50 annual renewal fee.

Although the CRM does not require continuing education credits, all GRMI members will receive an annual USD \$100 rebate when they attend a RIMS in-person workshop to further their professional development. Visit www.RIMS.org/Education for more information.

CRM-E Designation

If you hold the CRM designation and complete the RIMS Enterprise Risk Management workshop, you are eligible to take the CRM-E Online Examination in order to obtain your CRM-E designation.

The exam is based on the textbook, *Enterprise Risk Management*, published by the Institutes. Details and access information on the CRM-E Online Examination will be sent to you upon completion of the three-day workshop.



RIMS Fellow

GRMI also administers the RIMS Fellow (RF) designation, a symbol of professional excellence that affirms your mastery of risk management knowledge and commitment to quality. It represents the standard of education, dedication and ethics that the profession expects. Achieving the RF designation further verifies your qualifications as a risk professional.

To obtain the RF designation, you are required to:

- Complete an established risk management program
- Continually update your industry knowledge
- Contribute to the profession
- Demonstrate a high level of ethical behavior

RIMS provides courses, tools and opportunities to support your professional development efforts in obtaining the RF designation.
